

TOWN OF LARKSPUR, COLORADO
ORDINANCE NO. 7.71

AN ORDINANCE REASSIGNING THE DUTIES GIVEN THE TOWN CLERK FOR ADMINISTRATION OF THE SALES AND USE TAX ORDINANCE AND AMENDING ORDINANCE NO. 7.52 OF THE TOWN OF LARKSPUR, COLORADO

WHEREAS, Ordinance 7.52 of the Town of Larkspur, Colorado, provides generally for sales and use taxes to be imposed, collected and paid to the Town; and

WHEREAS, Ordinance 7.52 provides that the administration of the sales and use tax ordinance is vested in the Town Clerk; and

WHEREAS, the Town has determined that it is in the best interest of the welfare of the citizens of the Town to assign the duties of administration of the sales and use tax ordinance to a designee of the Town Council.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado, as follows:

Section 1. Section III(46) of Ordinance 7.52 is repealed and replaced with the following language:

(46) "Town Tax Official" means the person designated by the Town Council to administer and enforce this Ordinance.


Section 31. Subsection XLIX(2) of Ordinance 7.52 is amended to substitute "Town Tax Official" for "Town Clerk."
