

**TOWN OF LARKSPUR, COLORADO**  
**ORDINANCE NO. 7.73**

AN ORDINANCE APPROPRIATING SUMS OF MONEY TO VARIOUS FUNDS IN  
THE AMOUNTS AND FOR THE PURPOSES AS SET FORTH BELOW FOR THE  
1998 BUDGET YEAR FOR THE TOWN OF LARKSPUR, COLORADO

(THIS ORDINANCE HEREBY REPEALS AND SUPERCEDES ORDINANCE NO.  
7.71 PASSED THE 27<sup>th</sup> DAY OF JANUARY, 1998)

WHEREAS, the Town Council of the Town of Larkspur, Colorado adopted its annual budget in accordance with applicable law on January 27, 1998; and

WHEREAS, the Town Council made provisions therein for revenues in an amount equal to or greater than the total proposed expenditures, as set forth in said Budget; and

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided by the Budget to, and for the purposes described below, so as not to impair the operations of the Town;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado as follows:

Section 1: That the following sums are hereby appropriated from the revenue of each fund, to each fund for the purposes as stated:

GENERAL FUND

Current Operating Expenses	\$ 568,915
Transfer to Sewer Fund	\$ 85,000
Transfer to Road and Bridge Fund	\$ 33,000
Transfer to Parks and Recreation Fund	\$ <u>16,000</u>
Total	\$696,915

WATER FUND

Current Operating Expenses	\$ 184,511
Debt Service	\$ <u>9,517</u>
Total	\$194,028

SEWER FUND

Current Operating Expenses	\$ 171,498
Debt Service	\$ 3,130
Total	\$174,628

ROAD AND BRIDGE FUND





Section 2: This ordinance shall take effect five (5) days after it is posted, in accordance with Section 3.20 of the Town Charter.


