

ORDINANCE NO. 8.01

AN ORDINANCE INITIATING THE ADOPTION OF A HOMERULE
CHARTER FOR THE TOWN OF LARKSPUR AND PROVIDING FOR
THE ELECTION OF CHARTER COMMISSION MEMBERS

WHEREAS the Municipal Homerule Act of 1971, C.R.S. 1973,
31-2-201 et seq., as amended, authorizes the Board of Trustees
to initiate, by Ordinance, the adoption of a homerule charter;
and,

WHEREAS, the Board of Trustees desires to initiate the
adoption of a homerule charter for the Town of Larkspur.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES
OF THE TOWN OF LARKSPUR:

Section 1. INITIATION OF HOMERULE.

That the following question be submitted to a vote of the
registered electors of the Town of Larkspur in accordance with
the provisions of Article XX of the Colorado Constitution and
the Municipal Homerule Act of 1971, at a special election to
be held on the 16th day of December, 1980:

SHALL THE TOWN OF LARKSPUR FORM A HOMERULE
CHARTER COMMISSION?

Section 2. COMMISSION MEMBERS.

That at such election the registered electors shall
elect a total of nine members to the charter commission to
take office if the formation of the charter commission is
approved by the qualified electors.

Introduced as an Ordinance at a regular meeting of the
Board of Trustees of the Town of Larkspur, Colorado, on the
8th day of October, 1980, and passed by a vote of
5 for and 0 against and ordered published. *1 ABSENT.*

TOWN OF LARKSPUR
RESOLUTION TO ADOPT BUDGET

A resolution adopting a budget for the Town of Larkspur, Colorado, for the calendar year beginning on the first day of January, 1981, and ending on the last day of December, 1981.

WHEREAS the Board of Trustees of the Town of Larkspur has appointed Anna M. Trueblood, Mayor, to prepare and submit a proposed budget to said governing body at the proper time, and;

WHEREAS Anna M. Trueblood, Mayor, has submitted proposed budget to this governing body for its consideration, and;

WHEREAS Public Notice was published on October 1, 1980, and a public hearing was held on October 8, 1980, and interested taxpayers were given the opportunity to register any objections to said proposed budget, and;

WHEREAS whatever increases may have been made in the expenditures, like increases were added to the revenue so that the budget remains in balance, as required by law.

NOW THEREFOR BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LARKSPUR, COLORADO:

Section 1. That the budget as submitted and amended be, and the same is hereby approved and adopted as the budget of the Town of Larkspur for the year stated above.

Section 2. That the budget hereby approved and adopted shall be signed by the Mayor and the Town Clerk and made a part of the public records of the Town.

Section 3. That the budget hereby approved and adopted is attached hereto and made a part hereof.
