AN ORDINANCE APPROVING AN INTERGOVERNMENTAL AGREEMENT REGARDING THE SPRUCE MOUNTAIN ROAD (COUNTY ROAD 53) OVER EAST PLUM CREEK BRIDGE REPLACEMENT PROJECT STRUCTURE NO. LAR 53-07.20, TOWN OF LARKSPUR, COLORADO DOUGLAS COUNTY PROJECT NUMBER CI 05-017

WHEREAS, the Town is empowered to provide certain street and related improvements and repairs and maintenance thereof; and

WHEREAS, pursuant to Colorado Constitution, Article XIV, Section 18(2)(a), and Section 29-1-203, C.R.S., the Town and Douglas County ("the County") may cooperate or contract with each other to provide any function, service, or facility lawfully authorized to each, and any such contract may provide for the sharing of costs, or other matters, and

WHEREAS, the Town and the County desire to enter into that certain Intergovernmental Agreement regarding the Spruce Mountain Road (County Road 53) over East Plum Creek Bridge Replacement Project Structure No. LAR 53-07.20, Town of Larkspur, Colorado, Douglas County Project Number CI 05-017, (hereinafter the "IGA"), a copy of which is attached hereto and incorporated herein.

NOW THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO AS FOLLOWS:

- 1. The Town Council hereby approves the IGA.
- 2. The Town Council hereby authorizes the Mayor and the Town Clerk to execute all documents and take all steps necessary to carry out the IGA.
- 3. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Town Council hereby declares that it would have passed this ordinance and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

4. Repeal. Existing ordinances or parts of ordinances covering the same matters as embraced in this ordinance are hereby repealed and all ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.
