



ORDINANCE NO. 1.16

AN ORDINANCE TO PROVIDE COMPENSATION TO THE MAYOR AND TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO

THIS ORDINANCE HEREBY REPEALS AND SUPERSEDES THE FOLLOWING ORDINANCES

ORDINANCE # 1.11 PASSED AND ADOPTED January 15, 1998
ORDINANCE #1.09 PASSED AND ADOPTED April 6th 1994
ORDINANCE # 1.08 PASSED AND ADOPTED March 11th 1992
ORDINANCE # 1.04 PASSED AND ADOPTED April 7, 1986
ORDINANCE # 1.02 PASSED AND ADOPTED February 10, 1982

WHEREAS, the Town of Larkspur Charter Section 3.05 provides for the Town Council and the Mayor to receive compensation, and

WHEREAS, on March 18, 2010 the Town Council voted to raise the compensation to the following amounts;

NOW THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO AS FOLLOWS:

1. Any mayor who is elected, re-elected or appointed subsequent to the effective date of this ordinance, shall be compensated in the amount of \$6,000 (six thousand) per year paid monthly.
2. Any Council member, who is elected, re-elected or appointed subsequent to the effective date of this ordinance, shall be compensated in the amount of \$50 (fifty) per meeting (regular, special or work session) as long as the council member is in attendance at such meeting. This amount shall be paid monthly.
3. Any Town Council member who is currently in office, who was elected or appointed prior to the effective date of the ordinance, shall be compensated in the amount of \$25 (twenty-five) per meeting (regular, special or work session) as long as the council member is in attendance at such meeting. This amount shall be paid monthly.
4. Nothing in this Ordinance shall be construed to limit in any manner, the reimbursement of actual and necessary expenses incurred by the Mayor or members of the Town Council in the performance of the duties of their respective offices.




