

ORDINANCE NO. 4.14

AN ORDINANCE TO PROVIDE A CENTRAL  
TRASH FACILITY FOR USE OF RESIDENTS  
OF THE TOWN OF LARKSPUR, COLORADO

WHEREAS, the Town Council of the Town of Larkspur, Colorado has deemed it to be in the best interests of the residents of the Town to provide a central trash facility for use of residents of the Town; and

WHEREAS, the provision of such a facility which served to promote the health, safety, welfare and general prosperity of the residents of the town;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado, as follows:

ARTICLE 1

The Town of Larkspur may, from time to time, provide a central trash facility or facilities to be located at such place or places in the Town as may be directed by the Town Council. Nothing herein shall be construed to require the Town Council to furnish such a facility.

ARTICLE 2

The use of any such central facility is restricted to only bona fide residents of the Town of Larkspur, Colorado. Residency may be proved by a current Colorado driver's license or voter's registration card showing a residence within the Town limits.

ARTICLE 3

The Town Council may, from time to time, establish fees for the utilization of the central trash facility or facilities. In the event that the Town Council establishes such fees, no resident may utilize the central trash facility without payment of such a fee.

ARTICLE 4

The Town Council may from time to time, by resolution, authorize certain persons to enforce the terms of this Ordinance. Any person so authorized shall have the right to demand proof of residency prior to permitting use of the central

trash facility and shall also collect any fees which may be owing in connection therewith. Any person who does not show proof of residency or pay any applicable fees shall be prohibited from using the central trash facility. All non-residents are prohibited from using the central trash facility.

ARTICLE 5

Any person alleged to be in violation of any of the provisions of this Ordinance may be issued a Summons and Complaint to appear in the Municipal Court of the Town of Larkspur. Any person who violates any of the provisions of this Ordinance shall, upon conviction, be fined a sum not to exceed three hundred dollars (\$300.00) for each offense or confined in the County Jail for not more than 30 days, or both. Each occurrence of a violation of this Ordinance shall be deemed to be a separate offense.

Introduced as an ordinance at a regular meeting of the Town Council of the Town of Larkspur, Colorado, on the 8<sup>th</sup> day of July, 1987, and passed by a vote of 5 for and 0 against, and ordered published.
