## TOWN OF LARKSPUR, COLORADO ORDINANCE NO. 4.2/

AN ORDINANCE REASSIGNING THE DUTIES GIVEN THE TOWN CLERK FOR ADMINISTRATION OF THE TOWN PARKS AND RECREATIONAL AREAS USE ORDINANCE AND AMENDING ORDINANCE NO. 4.18 OF THE TOWN OF LARKSPUR, COLORADO

WHEREAS, Ordinance 4.18 of the Town of Larkspur, Colorado, regulates the hours and use of Town Parks; and

WHEREAS, Ordinance 4.18 provides that the Town Clerk shall accept applications and issue permits for use of the Town Parks; and

WHEREAS, the Town has determined that it is in the best interest of the welfare of the citizens of the Town to assign the duties of administration of the parks ordinance to a designee of the Town Council.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado, as follows:

Section 1. Section 4 of Ordinance 4.18 is amended to substitute "Town" for "Town Clerk."

Section 2. Section 5 and subsection (C) thereof of Ordinance 4.18 is amended to substitute "a member of the Town Council or a person designated by the Town Council to administer this Ordinance" for "the Town Clerk."

Section 3. The introductory clause to Section 6 of Ordinance 4.18 is amended to read as follows:

SECTION 6 -- STANDARDS FOR ISSUANCE: The Town Council or the Town Council designee shall issue a permit for use of a Town Park if the following factors are found:

Section 4. Section 7 of Ordinance 4.18 is amended to substitute "Town" for "Town Clerk."

Section 5. Section 8 of Ordinance 4.18 is amended to read as follows:

SECTION 8 -- APPEAL: Within five days

Section 6. Section 10 of Ordinance 4.18 is amended to read as follows:

SECTION 10 -- FEE SCHEDULE - RULES AND REGULATIONS: The Town Council shall set by resolution a fee schedule for the

use of any Park for residents and non-residents. In addition, the Town Council may establish by resolution such rules and regulations as may be necessary or desirable to effectuate the provisions of this Ordinance and/or to ensure that all Parks are safe, pleasant and efficiently operated and maintained.

Section 7. Subsection 12(A)(16) of Ordinance 4.18 is amended to substitute "Town" for "Town Clerk."

Section 8. Effective Date. This Ordinance shall take effect five (5) days after posting in accordance with Section 3.20 of the Charter of the Town of Larkspur.
