

TOWN OF LARKSPUR  
ORDINANCE NO. 5.10  
AN ORDINANCE AMENDING ORDINANCE NUMBER 5.07

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR,  
COLORADO:

SECTION I - PURPOSE

The Town of Larkspur, in order to promote orderly development, protect the health, safety, and welfare of its citizens, and to maintain a self-supporting water supply system for the benefit of the community hereby modifies certain fees, rates, charges, levies and regulations in order to maintain a self-supporting water supply system for the benefit of the community.

SECTION II - NEW SERVICE

Section IV, A., 1. of Ordinance Number 5.07 is hereby amended by adding Section IV, A., (1.), (a.):

The payment of a water tap fee shall entitle the user to tap the water main. The water tap shall be made at a location on the water main which shall be designated by the Town engineer. The cost of making the tap, including the setting of the meter, etc., and pit shall be paid by the user and shall be inspected and approved by the Town engineer of the Town of Larkspur. This section shall be apply to those tap fees paid on or after the effective date hereof.

SECTION III - PENALTY

Any person found in violation of any of the provisions of this ordinance may be issued a Summons and Complaint for appearance in the Municipal Court of the Town of Larkspur by the Town Council or Building Inspector of the Town of Larkspur, or any other agent thereof, and if convicted thereof, be punished by a fine not to exceed Three Hundred Dollars (\$300.00) or confinement in the County Jail for not more than thirty (30) days, or both.

SECTION IV - SEVERABILITY

Should any portion of this ordinance be determined to be unconstitutional by a Court of competent jurisdiction, that portion shall be determined to be severable and the balance of the ordinance shall remain in full force and effect.

SECTION V - EFFECTIVE DATE

Adopted at a regular meeting of the Town Council of the Town of Larkspur, Colorado on the 23rd day of November, 1983, passed by a vote of 4 for and 0 against and ordered published.


