

ORDINANCE NO. 7.39

AN ORDINANCE TO AMEND ORDINANCE 7.09,  
ORDINANCE 7.17 AND ORDINANCE 7.25 PERTAINING  
TO AN ADMISSIONS TAX

(This Ordinance hereby repeals and supercedes  
Ordinance No. 7.17, passed and adopted on December 5, 1984,  
and Ordinance No. 7.25, passed and adopted on February 4, 1987)

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR,  
COLORADO as follows:

Section 1. Purpose. The purpose of this Ordinance is to increase revenues which are derived from the collection of the admissions tax imposed by Ordinance No. 7.09 as amended by Ordinance No. 7.17 and Ordinance 7.25 upon certain events as defined therein held within the corporate limits of the Town of Larkspur, the revenue raised thereby to be used for the payment of the expenses of operating and improving the Town and its facilities.

Section 2. This Ordinance hereby repeals and supersedes Ordinance No. 7.17, passed on the 5th day of December, 1984. This Ordinance further repeals and supersedes Ordinance No. 7.25, passed on the 4th day of February, 1987.

Section 3. Section 5.2 of Ordinance No. 7.09 is hereby deleted in its entirety and the following substituted in its stead.

5.2 The amount of the tax hereby levied is seven percent (7%) of the price of each admission, provided that a tax derived from calculations resulting in a fraction of a cent being a part of the tax shall be increased or rounded to the next whole cent. If a block of admissions is sold to a single purchaser at a bulk rate, the tax shall be computed on the bulk rate in such cases instead of on individual admissions, provided that none of the tickets in the block are resold.

Section 4. Severability, should any portion of this ordinance be deemed to be unenforceable by a court of competent jurisdiction, that portion shall be determined to be severable

and the balance of the ordinance shall remain in full force and effect.

Introduced as an ordinance at a regular meeting of the Town Council of the Town of Larkspur, Colorado, on the 13th day of December, 1989, and passed by a vote of 6 for and -0- against, and ordered published.
