

ORDINANCE NO. 7.46

AN ORDINANCE APPROPRIATING ADDITIONAL SUMS OF MONEY TO DEFRAY EXPENSES IN EXCESS OF AMOUNTS BUDGETED FOR THE TOWN OF LARKSPUR, COLORADO FOR THE 1991 BUDGET YEAR (This Ordinance hereby repeals and supercedes Ordinance No. 7.43, passed and adopted on the 15th day of November, 1990)

WHEREAS, there is a need to transfer budgeted and appropriated money from one or more spending agencies in a fund to one or more spending agencies in another fund, and;

WHEREAS, it is necessary to use unappropriated surplus funds due to unforeseen expenses at the time the 1991 budget was adopted;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado as follows:

Section 1. This Ordinance hereby repeals and supercedes Ordinance No. 7.43, passed and adopted on November 15, 1990.

Section 2. The following sums of money are hereby appropriated from the revenue of each fund, to each fund, for the purposes stated:

Section 3. This ordinance and any rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect five (5) days after it is posted, in accordance with Section 3.20 of the Town Charter.
