ORDINANCE 7.47

AN ORDINANCE APPROPRIATING ADDITIONAL SUMS OF MONEY  
TO DEFRAY EXPENSES IN EXCESS OF AMOUNTS BUDGETED  
FOR THE TOWN OF LARKSPUR, COLORADO  
FOR THE 1991 BUDGET YEAR

(This Ordinance hereby repeals and supercedes  
Ordinance No. 7.43, passed and adopted on November 15, 1990,  
and Ordinance No. 7.46, passed and adopted on March 13, 1991)

WHEREAS, there is a need to transfer budgeted and  
appropriated money from one or more spending agencies in a fund  
to one or more spending agencies in another fund, and;

WHEREAS, it is necessary to use unappropriated surplus funds  
due to unforeseen expenses at the time the budget was adopted;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE  
TOWN OF LARKSPUR, COLORADO;

SECTION 1

This Ordinance hereby repeals and supercedes Ordinance No. 7.43,  
passed and adopted on November 15, 1989,  
and Ordinance No. 7.46, passed and adopted on March 13, 1991

SECTION 2

The following sums of money are hereby appropriated from the  
revenue of each fund, to each fund, for the purpose stated:
