

ORDINANCE 8.05

AN ORDINANCE SETTING FORTH THE BALLOT TITLE FOR THE CHARTER AMENDMENTS TO BE SUBMITTED TO THE ELECTORS OF THE TOWN OF LARKSPUR AT THE SPECIAL ELECTION TO BE HELD ON NOVEMBER 5, 1996, AND DESIGNATING THE ORDER OF THE BALLOT QUESTIONS TO BE VOTED UPON AT SAID ELECTION

BE IT ORDAINED by the Town Council of the Town of Larkspur, Colorado as follows:

Section 1. On September 4, 1996 the Town Council enacted Ordinance No. 8.04 submitting charter amendments to the Town of Larkspur at the special municipal election to be held on November 5, 1996.

Section 2. The ballot title for the amendments to be submitted pursuant to Ordinance No. 8.04 shall be as follows:

CHARTER AMENDMENT A

"SHALL THE LARKSPUR TOWN CHARTER BE AMENDED TO PROVIDE THAT THE TOWN CLERK IS TO BE ELECTED BY THE REGISTERED ELECTORS OF THE TOWN AND TO RESTATE THE DUTIES AND RESPONSIBILITIES OF THE TOWN CLERK?"

Section 3. For purposes of the notice to be published pursuant to C.R.S. 31-2-210, the highlighting indicating new material and the dashes through words indicating deletions shall be omitted so that the published notice shall contain the full text of the amendment, including the new material added and omitting the material to be deleted.

Section 4. The ballot title shall appear immediately prior to the text of the Charter amendment.

Section 5. The published notice shall otherwise comply with the requirements of C.R.S. 31-2-210.

Section 6. Notwithstanding anything to the contrary in Ordinance No. 7.67 or

Ordinance No. 7.68, the ballot shall designate the question to be submitted to the voters pursuant to Ordinance No. 7.67 as Ballot Question A and the question to be submitted to the voters pursuant to Ordinance No. 7.68 as Ballot Question B.

Section 7. This ordinance shall take effect five (5) days after it is posted, in accordance with Section 3.20 of the Town Charter.

Introduced as an Ordinance at a regular meeting of the Town Council of the Town of Larkspur, Colorado, on the 12th day of September, 1996, and passed by a vote of 3 for, 1 against, and 0 abstentions.
