

ORDINANCE NO. 6.16

TOWN OF LARKSPUR, COLORADO

AN ORDINANCE REPEALING ORDINANCES 6.13 AND 6.14 AND AMENDING ORDINANCES 6.05 AND 6.09 REGARDING GENERAL BUSINESS LICENSES AND TRANSIENT MERCHANT LICENSES WITHIN THE TOWN OF LARKSPUR, COLORADO

WHEREAS, the Larkspur Town Council has previously adopted Ordinances 6.13 and 6.14 establishing the fees for general business licenses and transient merchant licenses within the Town of Larkspur, Colorado by amending the provisions of Ordinances 6.05, and 6.09.

WHEREAS, the Town Council has determined that the fees charged by the Town for such licenses need to be updated and increased.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO, AS FOLLOWS:

1. Ordinances 6.13 and 6.14 are hereby repealed.
2. Section 5 of Ordinance 6.05 is amended in its entirety to read as follows:

**Section 5. Fees.** Every person, firm or corporation required to be licensed by the provisions of this Ordinance shall pay a fee of Twenty-five Dollars (\$25.00) for a calendar year license, if such license is purchased on or before March 31<sup>st</sup> of the effective year. The fee for renewal of a license shall be Twenty-five Dollars (\$25.00) if the license is purchased on or before March 31<sup>st</sup> of the effective year. If the new license or renewal license is purchased after March 31<sup>st</sup> of the effective year, then the fee for such license shall be Forty Dollars (\$40). No license shall be issued or renewed unless all sales, use and admission taxes and all other taxes, charges, fees or assessments owed to the Town have been paid current through the date the license is purchased or renewed.

3. Section 1.3.6 of Ordinance 6.09 is amended in its entirety to read as follows:

**1.3.6 License Fees.** Every person, firm or corporation required to be licensed by the provisions of this Ordinance shall pay a fee of Twenty-five Dollars (\$25.00) for a calendar year license, if such license is purchased on or before March 31<sup>st</sup> of the effective year. The fee for renewal of a license shall be Twenty-five Dollars (\$25.00) if the license is purchased on or before March 31<sup>st</sup> of the effective year. If the new license or renewal license is purchased after March 31<sup>st</sup> of the effective year, then

the fee for such license shall be Forty Dollars (\$40). No license shall be issued or renewed unless all sales, use and admission taxes and all other taxes, charges, fees or assessments owed to the Town have been paid current through the date the license is purchased or renewed.
