



ORDINANCE NO. 6.25

TOWN OF LARKSPUR, COLORADO

AN ORDINANCE AMENDING ORDINANCE 6.16 REGARDING GENERAL BUSINESS LICENSES AND TRANSIENT MERCHANT LICENSES WITHIN THE TOWN OF LARKSPUR, COLORADO (and amending section 3-1-50 and 6-3-110 of the Municode)

WHEREAS, the Larkspur Town Council has previously adopted Ordinances 6.16 establishing the fees for general business licenses and transient merchant licenses within the Town of Larkspur, Colorado by amending the provisions of Ordinances 6.05, and 6.09; and

WHEREAS, the Town Council has determined that the fees charged by the Town for such licenses need to be updated and increased.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LARKSPUR, COLORADO, AS FOLLOWS:

1. Section 5 of Ordinance 6.16 is amended in its entirety to read as follows:

Section 5. Fees. Every person, firm or corporation required to be licensed by the provisions of this Ordinance shall pay a fee of Forty-five dollars (\$45.00) for a calendar year license. The fee for renewal of a license shall be forty-five dollars (\$45.00) if the license is purchased on or before March 31st of the effective year. If the renewal license is purchased after March 31st of the effective year it will be considered late and the fee for such license shall be sixty dollars (\$60). No license shall be issued or renewed unless all sales, use and admission taxes and all other taxes, charges, fees, or assessments owed to the Town have been paid current through the date the license is purchased or renewed.

2. Section 1.3.6 of Ordinance 6.16 is amended in its entirety to read as follows:

1.3.6 License Fees.

Every person, firm or corporation required to be licensed by the provisions of this Ordinance shall pay a fee of Forty-five dollars (\$45.00) for a calendar year license. The fee for renewal of a license shall be forty-five dollars (\$45.00) if the license is purchased on or before March 31st of the effective year. If the renewal license is purchased after March 31st of the effective year, it is considered late and the fee for such license shall be sixty dollars (\$60). No license shall be issued or renewed

unless all sales, use and admission taxes and all other taxes, charges, fees, or assessments owed to the Town have been paid current through the date the license is purchased or renewed.

EFFECTIVE DATE

These fee increases will take effect for any business or transient business licences applied for or purchased for the calendar year 2018 and beyond.
