

PUBLIC NOTICE OF ELECTION

PUBLIC NOTICE IS HEREBY GIVEN that pursuant to law, an election will be held for the Town of Larkspur, in the County of Douglas and State of Colorado (the "Town"), on Tuesday, November 7, 2017.

The election will be conducted as a mail ballot election pursuant to the Town Charter and the Colorado Municipal Election Code of 1965. Ballots will be mailed to Colorado registered electors of the Town on October 16, 2017.

A ballot drop-off site is located at: 8720 Spruce Mountain Rd., Larkspur, and will be available Monday through Friday from 8 a.m. to 5 p.m., through November 6, and on Election Day, November 7, from 7 a.m. to 7 p.m. Ballots can also be returned to the Designated Election Official by mail per instructions contained in the ballot packet and must be received by 7 p.m. on Tuesday, November 7, to be counted. **With the exception of active military serving overseas, ballots received after 7 p.m. on November 7 will not be counted, regardless of postmark.**

At said election the following ballot issue will be considered:

BALLOT ISSUE A:

WITHOUT INCREASING TAXES, SHALL THE TOWN OF LARKSPUR DEBT BE INCREASED \$2,466,000 WITH A MAXIMUM TOTAL REPAYMENT COST NOT TO EXCEED \$5,500,000, (WHICH INCLUDES PRINCIPAL AND INTEREST), FOR THE PURPOSE OF FINANCING THE COSTS OF THE DESIGN, ENGINEERING, PERMITTING, ACQUISITION, INSTALLATION AND CONSTRUCTION OF WELL PUMPS, TREATMENT FACILITY, COLLECTION AND TRANSMISSION LINES, MEASURING AND CONTROL DEVICES AND RELATED FACILITIES AND IMPROVEMENTS, SUCH DEBT TO CONSIST OF LOANS, BONDS OR OTHER MULTIPLE FISCAL YEAR FINANCIAL OBLIGATIONS; SUCH DEBT TO BE PAYABLE FROM ANY AVAILABLE REVENUE OF THE TOWN, INCLUDING BUT NOT LIMITED TO THE 5 MILL PROPERTY TAX LEVY APPROVED BY THE VOTERS IN 2012, SALES TAX REVENUE, AND/OR WATER REVENUE; AND SHALL THE PROCEEDS OF SUCH DEBT BE COLLECTED AND SPENT AS A VOTER-APPROVED REVENUE CHANGE AND EXCEPTION TO THE LIMITS WHICH WOULD OTHERWISE APPLY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION (TABOR) OR ANY OTHER LAW?
