AN ORDINANCE DESIGNATING A PUBLIC PLACE WITHIN THE TOWN OF LARKSPUR FOR POSTING PUBLIC NOTICES

(This Ordinance hereby repeals and supersedes Ordinance No. 1.06 passed and adopted on October 1, 1986 and Ordinance No. 1.07 passed and adopted on January 15, 1992.)

1. Purpose. This Ordinance is adopted for the purpose of promoting the health, safety, convenience, order, prosperity and general welfare of the present and future inhabitants of Larkspur, Colorado, and is authorized by Section 3.20 of the Home Rule Charter of the Town of Larkspur, Colorado and by Senate Bill 91-33.
2. Designation of Posting Place. The public place for the posting of any legal notices, ordinances or other documents required to be posted pursuant to Town Charter or applicable state statutes, shall be the bulletin board at the new Larkspur Town Hall, located at 8720 Spruce Mountain Road, Larkspur, Colorado.
3. This Ordinance shall take effect five (5) days after it is posted, in accordance with Section 3.20 of the Town Charter.





1. Purpose.
